## - TERMS AND CONDITIONS SNAKEBITE MTB ADVENTURES BIKE RENTAL -

These terms and conditions aim to clarify the risks and responsibilities when renting a bicycle and / or booking and participating in a guided bicycle tour.

### 1. Definitions

In these terms and conditions the following terms are used as defined below:

- "Snakebite" refers to Snakebite MTB Adventures, Calle Albatera 9, 03724 Moraira / Teulada (Alicante), España, with VAT registration Y3647152-X and touristic license registration TA-217-A.
- The term "equipment" refers to any equipment rented from Snakebite MTB Adventures.
- "Client" refers to any person that rents one or more bicycles of Snakebite MTB Adventures.
- The term "bicycle rental contract" refers to an agreement between Snakebite MTB Adventures and a client.
- · "MTB" refers to mountain biking.

## 2. Responsibilities and safety rules

The client is responsible for taking care of the equipment provided, and the return at the end of the contract, in the same condition in which it was when rented. The client will be required to bear the cost of any damage, loss or theft.

The client is liable for any damage, whether material or personal, whether to oneself or a third party, occurring during the duration of this contract. Snakebite is in no way responsible.

Snakebite is responsible for ensuring the proper functioning of the equipment.

Bike rental and / or participation in a guided MTB tour is at the client's own risk. Mountain biking is an outdoor activity sport. Clients are expected to understand the risks involved in this type of sport.

The client is responsible to ensure he or she has adequate travel and / or medical insurance.

Clients are required to obey Spanish traffic laws all times. Clients are required to wear a helmet at all times.

The client is liable for payment of any fines, and/or judicial or extrajudicial costs arising from any penalty for events occurring during the duration of this contract.

# 3. Personal injury and mechanical failure

In the event of personal injuries, crash, accident or other emergency the client should always

contact medical authorities (Tel: 112).

For small repair and punctures Snakebite provides clients with a multi tool, spare inner tube,

pump and puncture repair kit. In the event of a mechanical failure - other than punctures -

Snakebite offers breakdown service for the client within a reasonable time and depending on

the distance from Moraira.

4. Fees

Prices of equipment rental are published on Snakebite's website (www.snakebite-mtb.com).

Snakebite reserves the right to change fees at any time without further notice.

If a client has ordered but not yet paid for a product, Snakebite guarantees the price for one

month from when the order was placed.

Late return of the bicycle will be charged at the relevant fee.

5. Duration, change, cancellation and termination of the contract

The start and termination of the contract is written in the contract between Snakebite and the

client.

In case the client needs to change the dates of the rental, Snakebite will try to accommodate

these changes without additional charges.

Once a contract has started, fees will not be returned, regardless whether the equipment has

been returned before the end date of the contract.

Snakebite applies the following cancellation policy:

Cancellation up to 7 days prior to the start of the contract: rental cost fully refunded.

Cancellation less than 7 days prior to the start of the contract: 100% rental cost may be

charged.

6. Privacy protection

## - Snakebite MTB Adventures PRIVACY POLICY -
